Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an administrative amendment to correct an omission. During the amendment to L8848 on October 2017, updates to waste acceptance volumes were authorised but the premises category table was not updated in error. No changes to the aspects of the original licence have been requested by the Licence Holder.
