1. Decision summary

The Delegated Officer has determined to make amendments to Licence L6297/1993/11. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act). The decision report for the Existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

Amendment/Application summary

Licence L6297/1993/11 is held by Cleanaway CO Pty Ltd (Licence Holder) for the Cleanaway Co Pty Ltd (Kwinana) (the Premises), located at Lot 15 on Plan 87731, Mason Road Kwinana Beach.

The Premises relates to the categories and the assessed production or design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L6297/1993/11.

On 12 January 2024, the Licence Holder submitted an application to the department to amend Licence L6297/1993/11 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to revise the waste storage and processing areas figure (Schedule 1, Figure 3) of the licence. The revision is required to rationalize storage and processing areas within the yard.

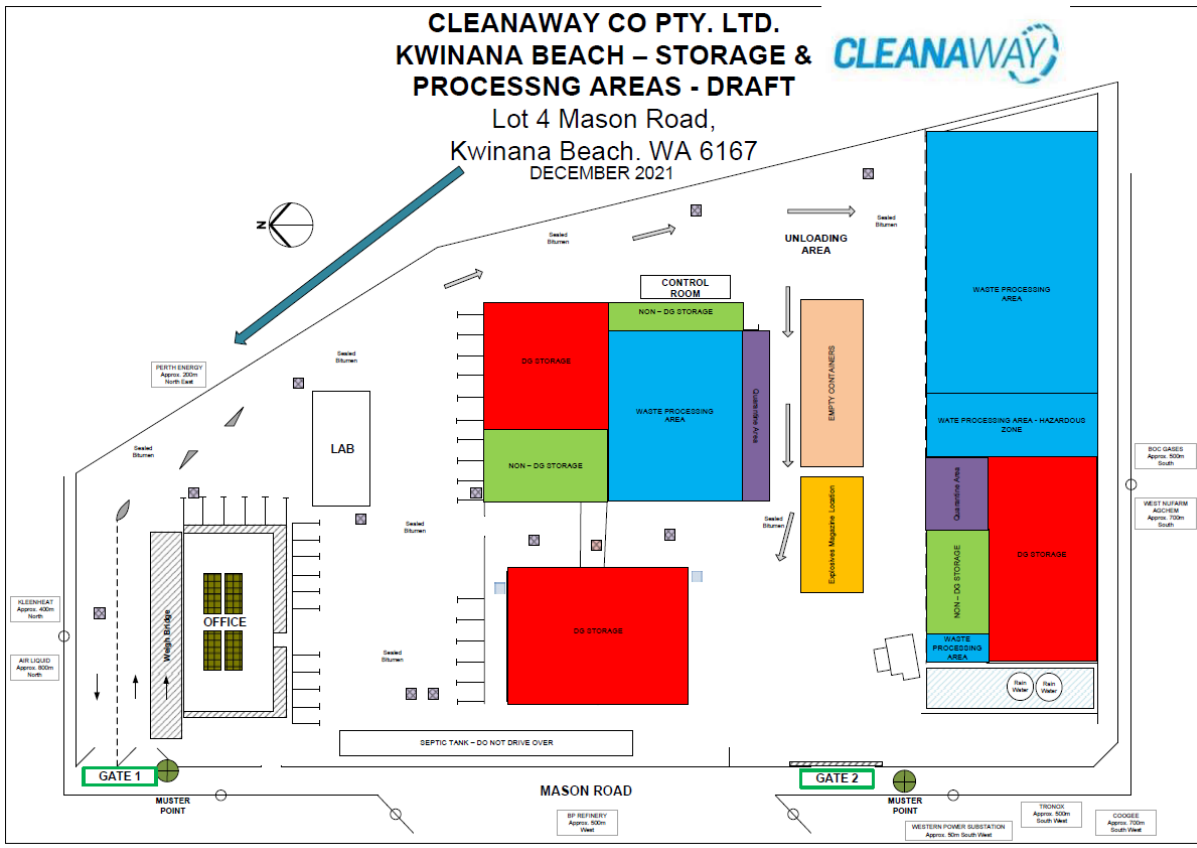


Figure 1: Current waste storage and processing areas

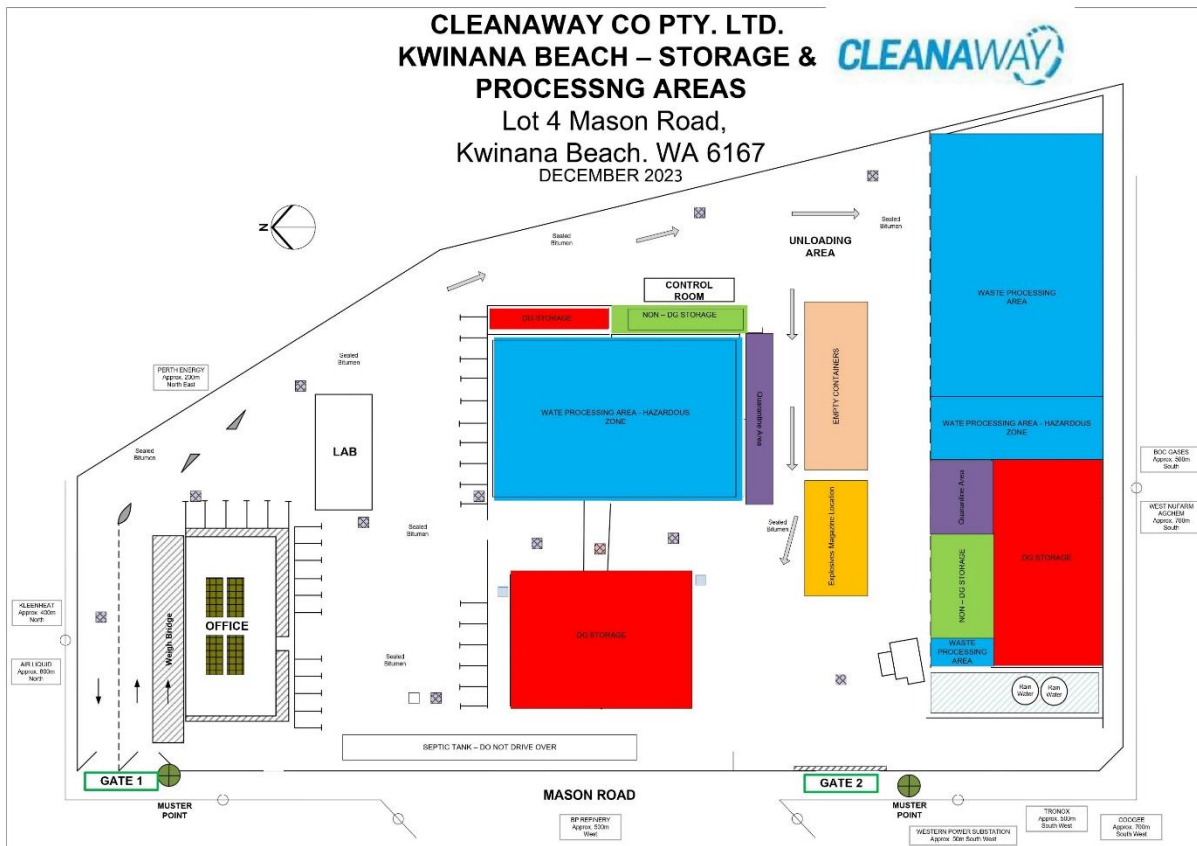


Figure 2: Proposed waste storage and processing areas

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 22 March 2024. The Licence Holder advised on 12 April 2024 they have no concerns with the proposed amendment.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
