#### 1. Decision summary

The delegated officer has determined to amend works approval W6576/2021/1 for Matsu Iron Ore Project to facilitate its transfer from Habrok (Rydges) Pty Ltd to Kimberley Metals Group Pty Ltd. As activities, emissions and receptors remain unchanged, the transfer is deemed administrative in nature and does not require a further risk assessment.

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

#### 2. Scope of assessment

#### 2.1 Regulatory framework

In making this decision, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

#### 2.2 Application summary and overview of premises

Works approval W6576/2021/1 is held by Habrok (Rydges) Pty Ltd for the Matsu Iron Ore Project (the premises), located at Mining Tenements Mining tenements G80/21 and M80/625 and Part of Mining tenements L80/82 and L80/84.

The premises relates to Category 5, Category 63, and Category 64 and the assessed production capacity under Schedule 1 of the Environmental Protection Regulations 1987 (EP Regulations) which are defined in existing works approval W6576/2021/1.

On 16 April 2025, Kimberley Metals Group Pty Ltd (the applicant) applied to transfer works approval W6576/2021/1 under section 59B of the *Environmental Protection Act 1986* (EP Act).

It should be noted that:

• The name of the current works approval holder, Habrok (Rydges) Pty Ltd, has been changed to Kimberley Metals Group Pty Ltd.

The scope of the transfer application is limited to changing:

- The works approval holder from Habrok (Rydges) Pty Ltd to Kimberley Metals Group Pty Ltd,
- The Australian Company Number (ACN) from 640 781 568 to 114 123 572, and
- The registered company address from REMAGEN '7', 17 Castlereagh Street, SYDNEY NSW 2000 to Level 1, 46 Hill Street, EAST PERTH WA 6004.

#### 3. Consultation

The works approval holder was provided with the draft decision report on 8 August 2025. Comments received from the works approval holder on 2 September 2025 have been considered by the delegated officer as detailed in Appendix 1.

#### 4. Decision

Kimberley Metals Group Pty Ltd has provided to the department evidence that they are now the legal occupier of the premises. Documents provided include the Department of Energy, Mines, Industry Regulation and Safety (DEMIRS) Tenement Register, ASIC extract and FTI Consulting confirmation. The department is satisfied that they are now the legal occupiers of the premises.

Correspondence regarding the transfer has been received from the nominated liquidator for Habrok (Rydges) Pty Ltd, FTI Consulting.

The delegated officer has determined to transfer Works Approval W6576/2021/1 to Kimberley Metals Group Pty Ltd on the grounds it is a current legal entity with legal access to the premises.
