1. **Decision summary**

The Delegated Officer has determined to make amendments to Works Approval W6713/2022/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W6713/2022/1 is held by Onslow Infraco Pty Ltd (Works Approval Holder) for the Ashburton Infrastructure Project – Port Landside and Nearshore (the Premises), located within part of Lot 555 on Deposited Plan 402556, and part of Lot 569 and 570 on Deposited Plan 71345.

The Premises relates to the category 58 – bulk material loading or unloading, and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6713/2022/1.

On 22 February 2024, the Works Approval Holder submitted an application to the department to amend Works Approval W6713/2022/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The proposed amendment is limited to a change to the premises boundary to better align with the most recent Pilbara Ports Authority Construction Licence for the Development of Ashburton Port Facility. The change to the boundary removes some multi-user areas and extends the boundary further seaward.

The applicant has provided a copy of the Pilbara Ports Authority Construction Licence to demonstrate that the proposed expansion of the premises boundary in the vicinity of the wharf and ship loader aligns with the Development area specified in Schedule 1 of the Construction Licence.

3. Consultation

The Pilbara Ports Authority was provided with a copy of the application documents on 25 March 2024. No comment was received.

The Works Approval Holder was provided with the draft Amendment Report on 10 April 2024. On 17 April 2024 the Works Approval Holder confirmed they had no comments and waived the remainder of the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the

determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
