1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6890/2025/1 (6890). The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Amendment summary

Works Approval W6890 is held by Quanxin Pty Ltd (Works Approval Holder) for the Xenon Recycle (the Premises), located at 14 Vinniciombe Drive, Canning Vale.

The Premises relates to the category/categories and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6890.

On 11 September 2025, the department initiated an amendment to Works Approval W6890. The amendment is limited to extending works approval Time-limited operations expiry date under Condition 6(a) to allow continued operation of the tyre recycling facility until a Licence Application is granted.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 12 September 2025. On 15 September 2025 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised works approval as part of the amendment process.
