**NOTIFICATION OF ISSUE OF VEGETATION CONSERVATION NOTICE PURSUANT TO SECTION 70(2) OF THE ENVIRONMENTAL PROTECTION ACT 1986**

Vegetation conservation notice CPS 7995/1 given to Trevor John Wessells for Lot 120 on plan 300098, Bannister, in the Shire of Wandering, requiring Trevor John Wessells to repair damage caused by unlawful clearing by ensuring that no further unlawful clearing takes place on the land and taking specified measures to revegetate 1160 native trees.

Vegetation conservation notice CPS 6968/1 given to Babindi Pty Ltd for Lot 4068 on plan 119174, Southern Brook, in the Shire of Northam, requiring Babindi Pty Ltd to repair damage caused by unlawful clearing by ensuring that no further unlawful clearing takes place on the land and taking specified measures to revegetate 103 native trees
