  - (i) if dated, refers to that particular version; and
  - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

**NOTE:** This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

### **Licence conditions**

The licence holder must ensure that the following conditions are complied with:

#### Infrastructure and equipment

**1.** The licence holder must ensure that the site infrastructure and equipment listed in Table 1 and located at the corresponding infrastructure location is maintained and operated in accordance with the corresponding operational requirement set out in Table 1.

#### **Premises operations**

2. The license holder shall ensure the annual production of material processed as a result of category 12 prescribed premises operations does not exceed 50,000 tonnes per annual period.

#### **Emissions and discharges**

3. The Licence holder shall implement the Dust Management Plan and additional dust control measures detailed in section 3.5 and section 3.7 of the document titled 'Offsite Impacts management Plan, Limestone and sand excavation, renewal of Limestone Quarry – Lots Pt 650, Pt 651 and Pt 652 and Pt 712, Lussky Road, Hope valley, City of Kwinana dated May 2015'.

### **Records and reporting**

- 4. All information and records required by the Licence shall:
  - (a) be legible;
  - (b) if amended, be amended in such a way that the original and subsequent amendments remain legible or are capable of retrieval;
  - (c) except for records listed in 4(d) be retained for at least 6 years from the date the records were made or until the expiry of the Licence or any subsequent licence; and

- (d) for those following records, be retained until the expiry of the Licence or any subsequent licence:
  - (i) off-site environmental effects; or
  - (ii) matters which affect condition of the land or waters.
- **5.** The licence holder must:
  - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
  - (b) prepare and submit to the CEO by no later than 30 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
- 6. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
  - (a) the name and contact details of the complainant, (if provided);
    - (b) the time and date of the complaint;
    - (c) the complete details of the complaint and any other concerns or other issues raised; and
    - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
- 7. The licence holder shall submit to the CEO an annual environmental report within 30 calendar days after the end of the annual period. The report shall contain the information listed in Table 2 in the format or form specified in that table.






Figure 2: Map of Sensitive Receptor distance from premises boundary.
