- **3.** The licence holder must:
  - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
  - (b) prepare and submit to the CEO by no later than 60 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
- 4. The licence holder must submit to the CEO by no later than 60 days after the end of each annual period, an Annual Environmental Report for that annual period for the conditions listed in Table 2, and which provides information in accordance with the corresponding requirement set out in Table 2.




Figure 1: Map of the boundary of the prescribed premises (shown in Magenta). This boundary is consistent with the cadastral boundary for Lot 301 on Deposited Plan 63655.

The boundary of the prescribed premises is shown in the map below (Figure 1).
