## Interpretation

In this licence:

- (c) where tables are used in a condition, each row in a table constitutes a separate condition;

  - (i) if dated, refers to that particular version; and
  - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

**NOTE:** This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

## Licence conditions

The licence holder must ensure that the following conditions are complied with:

### Infrastructure and equipment

1. The licence holder must ensure that the infrastructure and equipment specified in Table 1 is maintained in good working order and operated in accordance with the operational requirements specified in Table 1.

5.	a) 1.8m high fence around the perimeter of the site	i. Fence to be constructed of non-combustible materials; ii. maintained in good condition; and iii. gates locked when the site is unattended to prevent unauthorised access

2. The licence holder must ensure that all vehicles on the premises operate at speeds of 8km/h or less.

## Premises operation

3. The licence holder shall only accept waste on the premises if:
- (a) It is of a type listed in Table 2;
  - (b) The quantity accepted is below any quantity limit listed in Table 2;
  - (c) It meets any specification listed in Table 2.

4. The licence holder shall ensure that where waste does not meet the waste acceptance criteria set out in condition 3, it is removed from the premises by the delivery vehicle or, where that is not possible, stored in a quarantined storage area or container and removed to an appropriately authorised facility as soon as practicable.
5. The licence holder shall ensure that wastes accepted onto the premises are only subjected to the processes set out in Table 3, in accordance with any process limits described in Table 3.

## Monitoring

6. The licence holder shall undertake the monitoring in Table 4 according to the specifications in Table 4.

## Records and reporting

7. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
  - (a) the name and contact details of the complainant, (if provided);
  - (b) the time and date of the complaint;
  - (c) the complete details of the complaint and any other concerns or other issues raised; and
  - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
8. The licence holder must:
  - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
  - (b) prepare and submit to the CEO by no later than 30 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
9. The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
  - (a) the calculation of fees payable in respect of this licence;
  - (b) the processes undertaken in accordance with condition 5 of this licence;
  - (c) any maintenance of infrastructure and equipment that is performed in the course of complying with conditions 1 and 5 of this licence;
  - (d) monitoring programmes undertaken in accordance with condition 6 of this licence; and
  - (e) complaints received under condition 7 of this licence.
10. The books specified under condition 9 must:
  - (a) be legible;
  - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
  - (c) be retained by the licence holder for the duration of the licence; and
  - (d) be available to be produced to an inspector or the CEO as required.
11. The licence holder shall ensure that the CEO is notified of a breach of any limit specified in the licence as soon as practicable but no later than 5pm of the next usual working day.

- 12.** The licence holder shall ensure that the CEO is notified of any fire at the premises as soon as practicable but no later than 5pm of the next usual working day.
