Licence conditions

Waste acceptance

- **1.** The licence holder must only accept waste on the premises if:
 - (a) It is of a type listed in Table 1;
 - (b) The quantity accepted is below any quantity limited listed in Table 1;
 - (c) It meets any specification listed in Table 1.

2. Records and reporting

- The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
 - (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and
 - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
- **6.** The licence holder must:
 - (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
 - (b) prepare and submit to the CEO by no later than 30 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
- 7. The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
 - (a) the calculation of fees payable in respect of this licence;
 - (b) monitoring programme undertaken in accordance with condition 6 of this licence; and
 - (c) complaints received under condition 5 of this licence.
- **8.** The books specified under condition 7 must:
 - (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the licence holder for the duration of the licence; and
 - (d) be available to be produced to an inspector or the CEO as required.

- **9.** The licence holder must, within 7 days of becoming aware of any non-compliance with conditions of this licence, notify the CEO in writing of that non-compliance and include in that notification the following information:
 - (a) which condition was not complied with;
 - (b) the time and date when the non-compliance occurred;
 - (c) if any environmental impact occurred as a result of the non-compliance and if so what that impact is and where the impact occurred;
 - (d) the details and result of any investigation undertaken into the cause of the noncompliance;
 - (e) what action has been taken and the date on which it was taken to prevent the non-compliance occurring again; and
 - (f) what action will be taken and the date by which it will be taken to prevent the non-compliance occurring again.
- **10.** The licence holder must implement and maintain a system which ensures that a record is made of:
 - (a) the waste type, quantity and date of arrival of each load accepted at the Premises:
 - (b) the waste type, quantity, date of removal and destination (recycled material/recycling site/landfill etc.) of each load removed from the site; and
 - (c) rejected loads including details of the waste producer, waste carrier, and registration number of the vehicle and the date and reason for rejection.




Figure 1: Map of the boundary of the prescribed premises
