## Interpretation

In this works approval:

- (a) the words 'including', 'includes' and 'include' in conditions mean "including but not limited to", and similar, as appropriate;
- (b) where any word or phrase is given a defined meaning, any other part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (c) where tables are used in a condition, each row in a table constitutes a separate condition;
- (d) any reference to an Australian or other standard, guideline, or code of practice in this works approval:
  - (i) if dated, refers to that particular version; and
  - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

**NOTE:** This works approval requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this works approval.

## Works approval conditions

The works approval holder must ensure that the following conditions are complied with:

### **Construction phase**

#### Infrastructure and equipment

- 1. The works approval holder must:
  - (a) install the infrastructure and equipment;
  - (b) in accordance with the corresponding installation requirements; and
  - (c) at the corresponding infrastructure location.
  - as set out in Table 1.

#### **Compliance reporting**

- 2. The works approval holder must within 30 calendar days of an item of infrastructure or equipment required by Condition 1 being mobilised/installed:
  - (a) undertake an audit of their compliance with the requirements of Condition 1; and
  - (b) prepare and submit to the CEO an Environmental Compliance Report on that compliance.
- **3.** The Environmental Compliance Report required by Condition 2, must include as a minimum the following:
  - (a) certification by a third-party crushing/screening plant operator and fitter that the crushing and screening plant or component(s) thereof, as specified in condition 1, have been constructed in accordance with the relevant requirements specified in condition 1;

- (b) as constructed plans, photographs and a detailed site plan for each item of infrastructure or component of infrastructure specified in condition 1; and
- (c) be signed by a person authorised to represent the works approval holder and contains the printed name and position of that person.

### Time limited operations phase

#### **Commencement and duration**

- **4.** The works approval holder may only commence time limited operations for infrastructure identified in Condition 1 once the report required by Condition 2 has been submitted to the CEO by the works approval holder.
- 5. The works approval holder may conduct time limited operations:
  - (a) For a period not exceeding 180 calendar days from the day the works approval holder meets the requirements of Condition 4 for that item of infrastructure; or
  - (b) Until such time as a prescribed premises licence for that item of infrastructure is granted in accordance with Part V of the *Environmental Protection Act 1986*, and only where this occurs prior to the time period specified in condition 5(a).

#### **Time limited operations requirements**

6. During time limited operations, the works approval holder must ensure that the premises infrastructure and equipment listed in Table 2 and located at the corresponding location is maintained and operated in accordance with the corresponding operational requirement set out in Table 2.

#### Table 2: Operational requirements

7. The works approval holder must take all reasonable and practicable measures to prevent stormwater run-off becoming contaminated by the activities and operations undertaken at the premises.

- 8. The works approval holder shall immediately recover, or remove and dispose of, spills of environmentally hazardous materials including fuel, oil, or other hydrocarbons, whether inside or outside an engineered containment system.
- **9.** The works approval holder shall ensure that all material used for the recovery, removal, and/or disposal of environmentally hazardous materials is stored in an impermeable container prior to disposal at an appropriately authorised facility.

#### **Compliance reporting**

- **10.** The works approval holder must submit to the CEO a report on the time limited operations within 30 calendar days of the completion date of time limited operations or 30 calendar days before the expiration date of the works approval, whichever is the sooner.
- **11.** The works approval holder must ensure the report required by condition 10 includes the following:
  - (a) a summary of the time limited operations, including timeframes and amount of material processed;
  - (b) a review of performance and compliance against the conditions of the works approval and the Environmental Commissioning Report; and
  - (c) where the manufacturer's design specifications and the conditions of this works approval have not been met, what measures will the works approval holder take to meet them, and what timeframes will be required to implement those measures.

### **Records and reporting (general)**

- **12.** The works approval holder must record the following information in relation to complaints received by the works approval holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
  - (a) the name and contact details of the complainant, (if provided);
  - (b) the time and date of the complaint;
  - (c) the complete details of the complaint and any other concerns or other issues raised; and
  - (d) the complete details and dates of any action taken by the works approval holder to investigate or respond to any complaint.
- **13.** The works approval holder must maintain accurate and auditable books including the following records, information, reports, and data required by this works approval:
  - (a) the works conducted in accordance with Condition 1 of this works Approval;
  - (b) any maintenance of infrastructure that is performed in the course of complying with Condition 6; and
  - (c) complaints received under Condition 12.
- **14.** The books specified under Condition 13 must:
  - (a) be legible;
  - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;

- (c) be retained by the works approval holder for the duration of the works approval; and
- (d) be available to be produced to an inspector or the CEO as required.


