Works approval history

Interpretation

In this works approval:

- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This works approval requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this works approval.

Works approval conditions

Infrastructure and equipment

The works approval holder must ensure that the following conditions are complied with:

- **1.** The works approval holder must:
 - (a) construct and / or install the works;
 - (b) in accordance with the documentation; as detailed in Table 1.

Note 1: Where the details and commitments of the documents listed in condition 1 are inconsistent with any other condition of this works approval, the conditions of this works approval must prevail.

2. The works approval holder must construct each landfill cell to ensure that a separation distance of 2.6 m is achieved between the lowest elevation of the landfill cell and the highest natural elevation of groundwater that has been recorded in Appendix 25 of the *Works Approval Supporting Documentation*.

Compliance reporting

- **3.** The works approval holder must submit a compliance document to the CEO, following the construction of each of Cells 16 to 19 and Leachate Ponds A and B and prior to their respective commissioning.
- **4.** The compliance document must:
 - (a) certify that the works were constructed in accordance with the conditions of the works approval;
 - (b) be signed by a person authorised to represent the works approval holder and contain the printed name and position of that person within the company.
- **5.** The works approval holder must submit a CQA report to the CEO following the construction of each of Cells 16 to 19 and Leachate Dams A and B of the works and prior to their respective commissioning.
- 6. The report required by condition 5 must:
 - document the quality of the constructed landfill cells and leachate collection system;
 - (b) demonstrate that all requirements of the cell and pond specifications and CQA plan have been complied with; and
 - (c) be certified by a suitably qualified engineer.

Records and reporting (general)

- 7. The works approval holder must record the following information in relation to complaints received by the works approval holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
 - (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and
 - (d) the complete details and dates of any action taken by the works approval holder to investigate or respond to any complaint.
- 8. The works approval holder must maintain accurate and auditable books including the following records, information, reports, and data required by this works approval:
 - (a) the works conducted in accordance with conditions 1 and 2;
 - (b) any maintenance of infrastructure that is performed in the course of complying with condition 1 and 2;
 - (c) complaints received under condition 7.

- **9.** The books specified under condition 8 must:
 - (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the works approval holder for the duration of the works approval; and
 - (d) be available to be produced to an inspector or the CEO as required.
