Interpretation

In this licence:

- (b) where any word or phrase is given a defined meaning, any other part of speech or other grammatical form of that word or phrase has a corresponding meaning;
- (c) where tables are used in a condition, each row in a table constitutes a separate condition;
- (d) any reference to an Australian or other standard, guideline, or code of practice in this licence:
 - (i) if dated, refers to that particular version; and
 - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

Licence conditions

The licence holder must ensure that the following conditions are complied with:

Infrastructure and equipment

1. The licence holder must ensure that the site infrastructure and equipment listed in Table 1 and located at the corresponding infrastructure location is maintained and operated in accordance with the corresponding operational requirement set out in Table 1.

Emissions and discharges

2. The licence holder must ensure that spills of wastewater outside of engineered containment infrastructure are contained and cleaned up immediately.
3. The licence holder must ensure that the emissions specified in Table 2, are discharged only from the corresponding discharge point and only at the corresponding discharge point location.

4. The licence holder must manage the discharge of treated wastewater to the premises irrigation field such that:
 - a) sprinklers that are positioned to ensure even distribution of treated wastewater and capable of discharging wastewater over a 15 m radius each;
 - b) no irrigation generated run-off, spray drift or discharge occurs beyond the boundary of the defined irrigation area;
 - c) no soil erosion occurs;
 - d) irrigation does not occur on land that is waterlogged;
 - e) vegetation is maintained over the irrigation area; and
 - f) fencing with visible safety signage is installed and maintained to deter access.

Monitoring

5. The licence holder must monitor treated effluent for dust suppression in accordance with Table 3 and ensure that the emissions from the monitoring locations do not exceed the corresponding limits specified in that table.

6. The licence holder must ensure that:

- a) monitoring is undertaken in each monthly period such that there are at least 15 days in between the days on which samples are taken in successive months;
- b) monitoring is undertaken in each quarterly period such there are at least 45 days in between the days on which samples are taken in successive quarters.

7. The licence holder must ensure that analysis of non-continuous samples obtained pursuant to condition 5 is undertaken by a holder of a current accreditation from the National Association of Testing Authorities (NATA) for the methods of sampling and analysis relevant to the corresponding relevant parameter.

Records and reporting

- 8.** The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions from the premises:
- a) the name and contact details of the complainant, (if provided);
 - b) the time and date of the complaint;
 - c) the complete details of the complaint and any other concerns or other issues raised; and
 - d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.

- 9.** The licence holder must:
 - a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period; and
 - b) prepare and submit to the CEO by no later than 30 days after the end of that annual period an Annual Audit Compliance Report in the approved form.
- 10.** The licence holder must:
 - a) prepare a biennial environmental report that provides information in accordance with the requirements set out in Table 4 for the preceding two annual periods, and
 - b) submit that environmental report to the CEO by no later than 1 March in each year after the end of every second annual period (the first report being due on 1 March 2024, then biennially thereafter).

- 11.** The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
 - a) the calculation of fees payable in respect of this licence;
 - b) any maintenance of infrastructure that is performed in the course of complying with condition 1 of this licence;
 - c) monitoring programmes undertaken in accordance with condition 5 of this licence; and
 - d) complaints received under condition 8 of this licence.
- 12.** The books specified under condition 11 must:
 - a) be legible;
 - b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - c) be retained by the licence holder for the duration of the licence; and
 - d) be available to be produced to an inspector or the CEO as required.






Figure 3: Design layout of Passive WWTP infrastructure
