Interpretation

- (c) where tables are used in a condition, each row in a table constitutes a separate condition;
- (d) any reference to an Australian or other standard, guideline, or code of practice in this licence:
 - (i) if dated, refers to that particular version; and
 - (ii) if not dated, refers to the latest version and therefore may be subject to change over time;
- (e) unless specified otherwise, any reference to a section of an Act refers to that section of the EP Act; and
- (f) unless specified otherwise, all definitions are in accordance with the EP Act.

NOTE: This licence requires specific conditions to be met but does not provide any implied authorisation for other emissions, discharges, or activities not specified in this licence.

Licence conditions

The licence holder must ensure that the following conditions are complied with:

Infrastructure and equipment

1. The licence holder must ensure that the site infrastructure and equipment listed in Table 1 and located at the corresponding infrastructure location is maintained and operated in accordance with the corresponding operational requirement set out in Table 1.

Table 1: Infrastructure and equipment requirements

Site infrastructure and equipment	Operational requirement	Infrastructure location

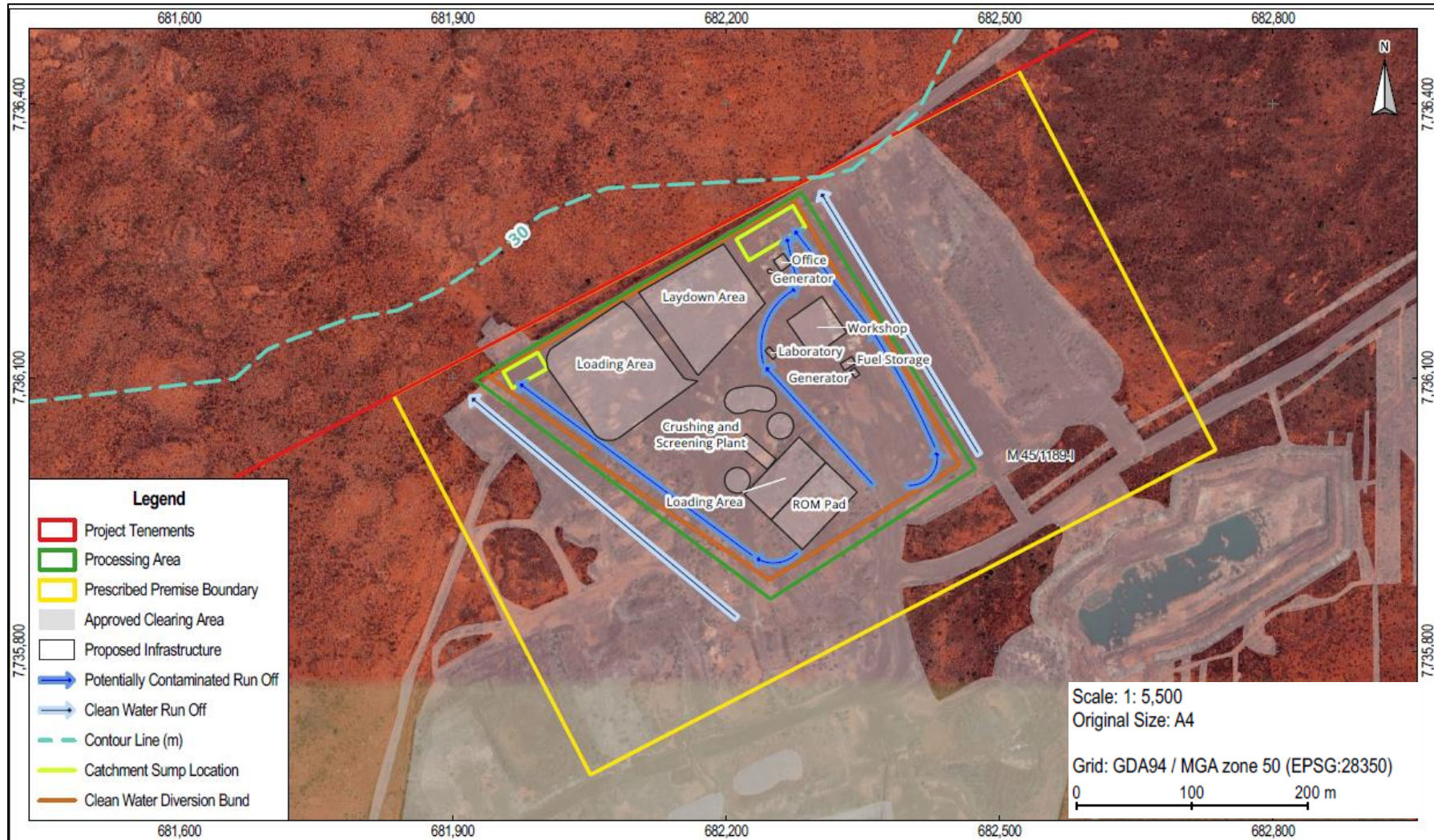


Figure 1. Prescribed premises boundaries and operational layout

Mobile Crushing and Screening Plant infrastructure and processing area	(a) Water sprays within the primary and secondary crusher and horizontal screener to be maintained in working order and operated to suppress any visible dust. (b) Water carts to be used to dampen work areas, access roads and stockpiles to minimise dust lift-off during storage and handling of crushed ore. (c) Vehicle speed limit restrictions to be enforced and reduction of speed limit to be implemented when dust is present. (d) All equipment to be maintained and operated in accordance with manufacturers specifications. (e) Control measures such as timers and motion sensors to be used to minimise light spill during night operations (f) Any light towers for night operations to have light directed downwards and partially shielded	Schedule 1, Figure 1.
Stormwater infrastructure	(g) Contaminated stormwater from the crushing and screening operations to be captured and prevented from being release into the environment. (h) Catchments sumps and bunds to be regularly checked and sediments removed to prevent overflow. (i) Uncontaminated stormwater from the surrounding area to be diverted around the crushing and screening operations.	Schedule 1, Figure 1.

2. The licence holder must ensure that no visible dust generated from the primary activities crosses the boundary of the premises.

Records and reporting

General

3. The licence holder must record the following information in relation to complaints received by the licence holder (whether received directly from a complainant or forwarded to them by the Department or another party) about any alleged emissions

Department of Water and Environmental Regulation

from the premises:

- (a) the name and contact details of the complainant, (if provided);
 - (b) the time and date of the complaint;
 - (c) the complete details of the complaint and any other concerns or other issues raised; and
 - (d) the complete details and dates of any action taken by the licence holder to investigate or respond to any complaint.
- 4.** The licence holder must maintain accurate and auditable books including the following records, information, reports, and data required by this licence:
- (a) the calculation of fees payable in respect of this licence;
 - (b) any maintenance of infrastructure that is performed in the course of complying with condition 1 of this licence; and
 - (c) complaints received under condition 3 of this licence.
- 5.** The books specified under condition 4 must:
- (a) be legible;
 - (b) if amended, be amended in such a way that the original version(s) and any subsequent amendments remain legible and are capable of retrieval;
 - (c) be retained by the licence holder for the duration of the licence; and
 - (d) be available to be produced to an inspector or the CEO as required.

Compliance reporting

- 6.** The licence holder must:
- (a) undertake an audit of their compliance with the conditions of this licence during the preceding annual period, and
 - (b) prepare and submit to the CEO by no later than 30 days after the end of the annual period, an Annual Audit Compliance Report in the approved form.
