A licence under the Environmental Protection Act 1986 (the Act) has been granted for the above premises. The Department of Environmental Regulation will advertise the issuing of this licence in the public notices section of The West Australian newspaper.

The licence includes attached conditions. Under Section 58(1) of the Act, it is an offence to contravene a condition of a licence. This offence carries a penalty of up to \$125,000 and a daily penalty of up to \$25,000

In accordance with section 102(1)(c) of the Act, you have 21 days to appeal the conditions of the licence. Under section 102(3)(a) of the Act, any other person may also appeal the conditions of the licence. Where a licence is issued for more than one year it requires payment of an annual fee and will cease to have effect if the fee is unpaid. It is the occupier's responsibility to lodge a fee application and pay the annual fee in sufficient time to avoid incurring a late payment fee and for processing to be completed before the licence anniversary date. #### PREAMBLE

### **Applicability**

This licence is issued to the Water Corporation for the operation of the Harvey Wastewater Treatment Plant located at Lot 270 on Plan 157787, Lot 271 on Plan 27968 and Lot 272 on Plan 5634, Wokalup which includes but is not necessarily limited to, the following operations:

Treatment of wastewater to a secondary standard through a series of three treatment ponds prior to flowing either directly to the Harvey Diversion Drain or through a woodlot and wetland, with overflow discharge to the Harvey Diversion Drain.

This facility is prescribed within Schedule 1 of the Environmental Protection Regulations 1987 as outlined in Table 1.

Table 1: Category under which Harvey WWTP is prescribed

# Nominal Rated Throughput

The nominal design capacity covered by this licence is 1100 cubic metres per day.

#### **Treatment Plant Performance**

The Director expects the Licensee to operate the treatment plant to achieve a target discharge contaminant concentration in treated wastewater of:

- 5-day Biochemical Oxygen Demand less than 20 mg/L;
- (b) Total Phosphorus less than 2mg/L;
- Escherichia coli less than 1,000 organisms per 100mL in treated wastewater discharged from the Premises.

#### **GENERAL CONDITIONS**

#### MONITORING AND REPORTING

- G1 The licensee shall provide to the Director, by **1 September each year**, an Annual Monitoring Report containing data collected over the previous financial year (**1 July to 30 June**). The report shall contain but not be limited to:
  - (i) monitoring data or other collected data required by any condition of this licence;
  - (ii) an assessment of the data against any limits set or other environmental guidelines, targets or policies referred to in this licence and data from previous years' monitoring;
  - (iii) a summary of any data exceeding those limits, guidelines, targets or policies including information on why the exceedance occurred (if known) and action taken by the Licensee to prevent recurrence of such exceedances.
  - (iv) a summary of the number and type of complaints received;
  - (v) any changes to site boundaries, location of groundwater monitoring bores, surface drainage channels and on-site or off-site impacts or pollution; and
  - (vi) a list of any monitoring methods used to collect and analyse data required by any condition of this licence to demonstrate they comply with the methods specified in this licence.
- The licensee shall by 1 September in each year, provide to the Director an annual audit compliance report in the form of Attachment 2 to this licence, signed and certified in the manner required by Section C of the form, indicating the extent to which the licensee has complied with the conditions of this licence, and any previous licence issued under Part V of the Act for the Premises, during the period beginning 1 July the previous year and ending on 30 June in that year.

#### WATER POLLUTION CONTROL CONDITIONS

#### MAINTENANCE OF WASTEWATER TREATMENT PONDS

- W1 The licensee shall manage the wastewater treatment ponds such that:
  - (i) uncontaminated stormwater runoff resulting from roof and site drainage shall not enter the wastewater treatment ponds or cause erosion of outer pond embankments:

<sup>&</sup>quot;mg/L" and "m<sup>3</sup>/day" mean milligrams per litre and cubic metres per day, respectively; and

<sup>&</sup>quot;premises" means Harvey Wastewater Treatment Plant located at Lot 270 on Plan 157787, Lot 271 on Plan 27968 and Lot 272 on Plan 5634 Acacia Road, Wokalup (as depicted in Attachment 1).

- (ii) overtopping of the ponds shall not occur except as a result of an extreme rainfall event [greater than a 1 in 100 year event of 72 hours duration];
- (iii) there is no discernible seepage loss from the treatment ponds;
- (iv) vegetation (emergent or otherwise) and debris shall be routinely removed from pond wastewaters or inner pond embankments; and
- (v) trapped overflows shall be minimized around the discharge from all wastewater treatment ponds to prevent carry-over of surface floating matter to subsequent ponds.

# FLOW MONITORING DEVICE

W2 The licensee shall maintain metering devices for measuring **monthly cumulative volumes** of treated wastewater discharged from the treatment plant to the Harvey Diversion Drain. The monthly flow results shall be presented in the next annual monitoring report in a tabular format in m³/day.

#### **ENVIRONMENTAL MONITORING PROGRAMME**

W3 The licensee shall take and have analysed, representative water samples from Table 1 at the monitoring sites shown in Column 1, at the frequency shown in Column 2 for the parameters shown in Column 3:

Sampling frequency	Parameters to be measured
Monthly	pH, 5-day Biochemical Oxygen Demand, Total Dissolved Solids, Total Suspended Solids, Nitrate + Nitrite-nitrogen, Ammonium-nitrogen, Total Nitrogen, Total Phosphorus and Escherichia coli.

Table 1: With the exception of pH and Escherichia coli, all measurements are to be reported in mg/L.

# SAMPLE ANALYSIS

- W4(a) The licensee shall collect all water samples in accordance with the relevant parts of Australian Standard 5667.
- W4(b) The licensee shall submit all water samples to a laboratory with current NATA accreditation for the analyses specified, and analysed in accordance with the current "Standard Methods for Examination of Water and Wastewater-APHA-AWWA-WEF".

# CALCULATION OF CONTAMINANT LOAD

W5 The licensee shall determine the monthly load of each contaminant in the treated wastewater discharged from the final pond and into the Harvey Drain (except pH and *Escherichia coli*) using flow-weighted data. The loads shall be based on the treated wastewater discharge rates and the concentrations as measured in accordance with condition W2 and W3. Monthly and annual average loads of the contaminants shall be reported in the Annual Monitoring Report in kilograms per day.

### BUNDING AND CONTAINMENT

- W6(a) The licensee shall store environmentally hazardous chemicals including alum and hypochlorite (where the total volume of each substance stored on the premises exceeds 250 litres) in accordance with AS3780.
- W6(b) The licensee shall ensure that perimeter valves on bunded areas are locked or otherwise secured in the closed position whilst the site is unattended.

#### SOLID WASTE POLLUTION CONTROL CONDITION

#### POND AND SOLIDS MANAGEMENT

- S1(a) The licensee shall dispose of collected vegetation and floating debris from the treatment ponds to a licensed or registered landfill.
- S1(b) The licensee shall:
  - inform the Director prior to taking a treatment pond offline for maintenance works;
  - (ii) inform the Director no less than 14 days prior to the removal of sewage sludge from a treatment pond;
  - (iii) where sewage sludge is temporarily stored on-site, direct sewage sludge to a hard-stand area or approved drying bed which;
    - (a) is adequately bunded to prevent surface runoff of leachate or sludge from crossing the boundary of the Premises; and
    - (b) return sludge leachate from the storage area back to the treatment ponds.
- S1(c) The licensee shall dispose of sludge and biosolids in accordance with the document Western Australian Guidelines Biosolids Management, Department of Environment and Conservation (December, 2012).


