Under Section 58 of the Environmental Protection Act 1986, it is an offence to contravene a licence condition. This offence carries a penalty of up to \$125,000, with a daily penalty of up to \$25,000.

PREAMBLE

The following statements in this Preamble either paraphrase sections of the Environmental Protection Act 1986 or provide relevant background information for the licence holder. They should not be regarded as conditions of licence.

Applicability

This licence is issued to the Water Corporation for the Lancelin Wastewater Treatment Plant (WWTP) located at Lot 1 on Diagram 66878 Lancelin Road, Lancelin, which is a prescribed premises within Schedule 1 of the *Environmental Protection Regulations* 1987, and includes but is not necessarily limited to, the following operations:

- · Sewage treatment; and
- Liquid waste treatment.

This facility is prescribed within Schedule 1 of the *Environmental Protection Regulations 1987* as outlined in Table 1.

Table 1: Category under which Lancelin WWTP is prescribed.

61	Liquid waste facility	Premises on which liquid waste produced on other premises (other than sewerage waste) is stored, reprocessed, treated or irrigated.
54 noils/anaa/	Sewage facility	Premises – (a) on which sewage is treated (excluding septic tanks); or (b) from which treated sewage is discharged onto land or into waters.

Nominal Rated Throughput

The nominated throughput of the premises covered by this licence is in accordance with the following:

· Quantity of liquid waste accepted for treatment:

more than 100 but less than 10,000

tonnes per year

Quantity of sewage waste accepted for treatment:

less than 200 cubic metres per day

Odour Control

The licence holder should manage and operate the premises such that odours emanating from the premises do not unreasonably interfere with the health, welfare, convenience, comfort or amenity of any person at an odour sensitive premises

Other Legal Requirements

The licensee should be aware that these conditions do not exempt the premises/licensee from other statutory obligations under the *Environmental Protection Act 1986*.

Emergency, Accident or Malfunction

The licensee should inform the Director as soon as practicable of the identification of any discharge of waste which has occurred as a result of an emergency, accident, malfunction or extreme weather conditions otherwise than in accordance with any condition of this licence, and has caused or is likely to cause pollution.

Alteration to Premises

Prior to making any significant alterations to the premises which may affect the air, water or noise emissions from the premises the licensee must submit a proposal to the Director accompanied by supporting information and plans which allow the environmental impact of that change to be assessed.

General Requirements

The following statements reflect important sections of the *Environmental Protection Act 1986* and are included for the information of the licensee:

- The licensee should take all reasonable and practicable measures to prevent pollution of the environment.
- Noise emissions from operations on site are required to comply with the *Environmental Protection (Noise) Regulations* 1997.
- The licensee should take all reasonable and practicable measures to prevent or minimise the discharge of waste and the emission of noise or odours from the premises.
- The licensee should inform the Director at least 24 hours prior to the commencement of any planned non-standard operations, which may have the potential to cause pollution.

"liquid waste" for the purpose of this licence means waste derived from a septic tank or grease trap;

"NATA" means National Association of Testing Authorities;

"premises" means Lancelin Wastewater Treatment Plant, located at Lot 1 on Diagram 66878 Lancelin Road, Lancelin (as depicted in Attachment 1);

"sewage waste" means human excreta or domestic waterborne waste; and

"wastewater treatment plant sludge" means, for the purpose of this licence, semi-solid material or precipitate produced in the wastewater treatment ponds as a result of the sewage waste and liquid waste treatment process.

GENERAL CONDITIONS

REPORTING REQUIREMENTS

- G1(a) The licensee shall provide the Director with an Annual Monitoring Report containing the monitoring data or other collected data required by any condition of this licence. The report shall contain data collected from each financial year (1 July to 30 June) and shall be provided by 1 September each year.
- G1(b) The licensee shall ensure that the Annual Monitoring Report specified in part (a) of this condition shall include, but not be limited to:
 - (i) an analysis of the data against any limits set in this licence; and
 - (ii) a description of any monitoring methods used to collect and analyse data required by any condition of this licence to demonstrate they comply with the methods specified in this licence.

ANNUAL AUDIT COMPLIANCE REPORT

G3 The licensee shall by 1 February in each year, provide to the Director an Annual Audit Compliance Report in the form in Attachment 2 to this licence, signed and certified in the manner required by Section C of the form, indicating the extent to which the licensee has complied with the conditions of this licence, and any previous licence issued under Part V of the Act for the premises, during the period beginning 1 January in the previous year and ending on 31 December in that year.

WATER POLLUTION CONTROL CONDITIONS

WASTEWATER TREATMENT

W1 The licensee shall direct all liquid waste and wewage waste received at the premises to the wastewater treatment ponds (as depicted in Attachment 1).

GROUNDWATER SAMPLING REQUIREMENTS

W2(a) The licensee shall collect groundwater samples at the monitoring sites and at the frequencies stated and have them analysed for the parameters listed in Table 2.

- W2(b) The licensee shall ensure that all groundwater samples, referred to in condition W2(a), are collected in accordance with Australian Standard 5667.
- W2(c) The licensee shall ensure that all groundwater samples, referred to in condition W2(a), shall be analysed in a laboratory holding NATA accreditation for the analyses specified.
- W2(d) The licensee shall ensure that all groundwater samples, referred to in condition W2(a), shall be analysed in accordance with the current "Standard Methods for Examination of Water and Wastewater, APHA-AWWA-WEF.

MANGEMENT OF THE WASTEWATER STORAGE PONDS

- W3 The licensee shall manage and operate the wastewater treatment ponds in a manner such that:
 - (i) uncontaminated stormwater runoff resulting from roof and site drainage is prevented from entering the treatment ponds;
 - (ii) overtopping of the ponds shall not occur except as a result of extreme rainfall events; and
 - (iii) there is no discernible seepage loss from the ponds.

SOLID WASTE DISPOSAL CONDITIONS

POND AND SOLIDS MANAGEMENT

- S1(a) The licensee shall dispose of collected vegetation and floating debris from the treatment ponds to an appropriate landfill facility.
- S1(b) Where wastewater treatment plant sludge is temporarily stored on-site, the licensee shall direct wastewater treatment plant sludge to a hard-stand area or approved drying bed which;
 - (a) is adequately bunded to prevent surface runoff of leachate or sludge from crossing the boundary of the premises;
 - (b) where possible returns sludge leachate from the storage area back to the treatment ponds.
- S1(c) The licensee shall dispose of wastewater treatment plant sludge and biosolids in accordance with the document Western Australian Guidelines for Direct Land Application of Biosolids and Biosolids Products, Department of Environmental Protection, Water and Rivers Commission and Department of Health (February, 2002).

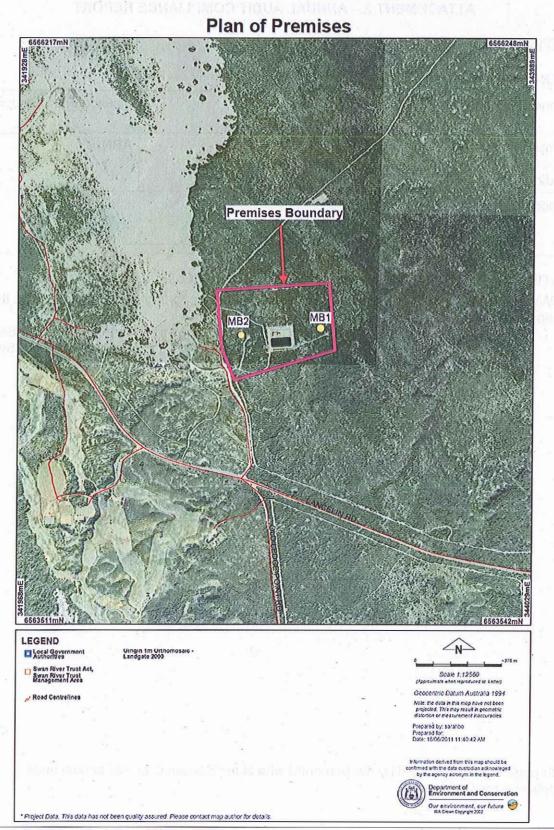
