Reason for Which this Notice is Served

This Notice is issued because I suspect on reasonable grounds that:

(a) a condition of pollution is likely to arise or has arisen.

Requirements of this Notice

The Occupier of the Premises who is bound by this Notice is required to do the following:

- Prior to 09:00 hours (9.00 a.m.) on 2 December 2008:
 - a) remove all visible abrasive blasting waste material from the Premises to a Department of Environment and Conservation approved waste disposal or recycling facility; or
 - b) i) clean up all visible abrasive blasting waste material within the boundary of the Premises; and
 - ii) store all visible abrasive blasting waste material in a manner that ensures no dust escapes the boundary of the Premises.
- 2 Post 09:00 hours (9.00 am) on 2 December 2008:
 - a) Clean up all visible abrasive blasting waste material at the conclusion of each abrasive blasting operation;
 - b) At least once a week, store all visible abrasive blasting waste material in a manner that ensures no dust escapes the boundary of the Premises; and
 - c) At least once a week, remove all un-usable stored visible abrasive blasting waste material from the Premises to a Department of Environment and Conservation approved waste disposal or recycling facility.
- Not conduct metal coating activities that cause overspray to escape the boundary of the Premises.

Not conduct abrasive blasting activities that cause dust or particulate matter to escape the boundary of the Premises.
