Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This is a DWER initiated amendment to correct a clerical error within condition 12 of Licence L5275/1972/12. This notice is limited only to an amendment for Category 64.

Amendment description

The risk assessment for Licence amendment (issued 19 May 2016) included the disposal of Special Waste Type 2 at Paraburdoo putrescible landfill. Condition 12 of the Licence specifies the waste types that are authorised to be accepted and buried at the putrescible landfill. Special Waste Type 2 was omitted in error. This amendment is to correct the clerical error within condition 12 and include Special Waste Type 2 as a waste type that can be accepted and buried at the Premises putrescible landfill.

Decision

Condition 12 of the Licence is amended by the inclusion of Special Waste Type 2 as a waste type that can be accepted and buried at the Premises putrescible landfill. The disposal of this waste type was assessed during the amendment dated 19 May 2016 but was not included as a waste type within condition 12.

Licence Holder's comments

The Licensee was provided with the draft Amendment Notice on 9 October 2017. Confirmation of no comments was received on 31 October 2017.

Amendment

1. Condition 12 of the Licence is amended by the deletion of the text shown in strikethrough below and the insertion of the bold text shown in underline below:

- 12 *MANAGEMENT OF PUTRESCIBLE LANDFILL (ATTACHMENT 4)*
The Licensee shall accept and bury only the following types of waste at the putrescible landfill facility:
 - (i) *Clean Fill;*
 - (ii) *Inert Waste Type 1;*
 - (iii) *Putrescible Waste; ~~and~~*
 - (iv) *Special Waste Type 1; and*
 - (v) **Special Waste Type 2**
as defined in the Landfill Definitions.
