Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to the maps in Schedule 1: Maps. No changes to the aspects of the original licence have been requested by the Licence Holder.

Amendment description

The Licence Holder has applied for an amendment to update the maps contained in Schedule 1 of the Licence. These maps contain the following changes:

- A new premises boundary map that has been updated under provisions of Ministerial Statement No: 719;
- An updated map of the ambient air monitoring locations that have been relocated due
 to operational changes. Specifically AQ2 has been relocated due to the pending
 construction of a haul road. AQ3 has been relocated closer to the new premises
 boundary to more accurately measure dust levels leaving the site.
- Other maps have been updated with the new premises boundary. No other changes are recorded.

Decision




The Licence Holder was provided with the draft Amendment Notice on 26 February 2019. No comments were received from the Licence Holder.


1. The Licence prescribed premises boundary is amended by the removal of the map *Premises map* from Schedule 1 of the licence and the insertion of the map below:




