Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

The current licence was issued on 25 September 2015. The licence contains a typographical error in Table 2.2.2 (condition 2.2.2 - emissions to land), which incorrectly states the averaging period for the parameter biological oxygen demand (BOD $_5$) as annual (30kg per hectare per year). The Licence Holder has identified that the previous licence (L6112/1996/10) stipulated the limit for BOD $_5$ as 30kg per hectare per day and has requested that this error is corrected in the current licence.

Decision

The licence has been amended to include the correct BOD₅ nutrient loading limit of 30 kg per hectare per day, which is consistent with the previous licences (L6112/1996/10 and L6112/1996/9).
