Amendment description

The current licence held by the Water Corporation (Licence Holder) for the Fitzroy Crossing Wastewater Treatment Plant is due to expire on 31 October 2018. The Department of Water and Environmental Regulation (DWER) has issued this administrative amendment to extend the expiry date of the licence for a further 10 years.

Decision

The Delegated Officer considers that a full review of the premises as part of a licence renewal process is not warranted at this time as the premises is low risk and DWER's Environmental Standards for Wastewater Treatment Facilities have not been developed as yet. A full review of the Fitzroy WWTP licence will be considered as part of DWER's risk-based licence review programme. The extension does not alter the risk profile of the premises and a detailed risk assessment is not required.

The Delegated Officer has granted the Amendment Notice 1 with a 10 year extension to the expiry date.

Licence Holder's comments

The Licence Holder was provided with the draft Amendment Notice 1 on 25 September 2018. The Licence Holder advised on 10 October 2018 that they do not have any comments on the proposed Amendment Notice.

Amendment

1. The licence expiry date has been extended from *Wednesday*, 31 October 2018 to 31 October 2028.
