Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the licence L7967/2003/6 issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to the definition of the annual reporting period contained in the Licence. No change to any other aspect of the original Licence has been requested by the Licence Holder.

Amendment description

On 26 February 2018, Savannah Nickel Mines Pty Ltd (Licence Holder) submitted an application to DWER for an amendment to the Savannah Nickel Project operational licence L7967/2003/6. The Licence Holder has requested an amendment to the definition of the term 'Annual period' from being the period between '1 January – 31 December' to the period from '1 July – 31 June'. An administrative error was made when the licence was last amended in July 2016 and the Licence Holder wishes to correct this as all other reporting is based on the financial year.
