Amendment

The Chief Executive Officer (CEO) of the Department of Environment Regulation (DER) has amended the above licence in accordance with section 59 of the *Environmental Protection Act 1986* as set out in this Amendment Notice.

Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

Licence L8344/2009/2 was amended in February 2016 to require the Licence Holder to construct a new stormwater retention pond at the site with an engineered liner and sufficient storage capacity. Due to circumstances beyond the Licence Holder's control, the completion date specified in the licence could not be met. Therefore, DER amended the licence in March 2016 to allow a further six weeks for completion of the improvements. The design report for a new stormwater retention pond and drainage infrastructure was received by DER on 11 May 2016. The Licence Holder is currently seeking a native vegetation clearing permit from DER and has applied to extend the construction completion date of the pond to 15 December 2016 to allow time to obtain the permit.

Decision

The design report required to be submitted by the Licensee in improvement requirement IR1 of condition 2.1.2 has been received by DER. Therefore, as this requirement is complete, it has been removed from the licence. The date of completion to install the new stormwater retention pond and drainage infrastructure has been extended to 15 December 2016 to allow the Licence Holder time to obtain a native vegetation clearing permit.
