## Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to change the boundary of the prescribed premises and to incorporate relevant administrative changes.

## Amendment description

This Amendment Notice is the result of an applicant initiated amendment and relates to the re-definition of the premises boundary to reflect the operational area for the Category 12: Crushing and screening activities. No changes are proposed in the operations at the premises and no changes are expected in discharges and emissions from the premises.

Through this Amendment Notice, amendments have also been made to the licence to reflect administrative changes as outlined in DWER's *Operational Procedure IR-OP-02 Redundant Conditions*.
