# **Amendment Notice**

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

# **Amendment Description**

This Amendment Notice is the result of a DER initiated amendment and relates to an administrative change to correct the date of submission of the Annual Environmental Report (AER).

## **Decision**

The annual reporting period for Licence L8357/2009/2 is the inclusive period from 1 June until 31 May in the following year. Condition 5.2.1 of the licence requires the Licence Holder to submit an Annual Environmental Report to DER by 31 May in each year. As the reporting date is the same date as the end of the annual period, the condition does not allow the Licence Holder any time to prepare the report. Therefore, the Delegated Officer has changed the Annual Environmental Report submission date in condition 5.2.1 to 31 July in each year to allow the Licence Holder sufficient time to prepare the report.
