Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment for Category 5. No changes to the aspects of the original Licence relating to Categories 6, 52, 57 or 64 have been requested by the Licence Holder.

The following guidance statements have informed the decision made on this amendment:

- Guidance Statement: Regulatory Principles (July 2015)
- Guidance Statement: Decision Making (February 2017)
- Guidance Statement: Risk Assessment (February 2017)

Amendment description

This amendment is the result of an application made by the Licence Holder on 21 June 2018 to increase the category 5 production rate of the existing processing plant by 1 Mtpa to 5.5Mtpa. No changes to the infrastructure are planned nor changes to the existing tailings discharge method and rates. The increase in processing capacity is achieved through optimisation of the upgraded processing circuit ('Recovery Enhancement Project') and related infrastructure (upgrades to the power station) which were previously assessed in the licence amendment dated 27 February 2017.

Consequently no further risk assessment is required for this amendment.
