Amendment Notice

Amendment description

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to extend the licence duration and has been initiated by DWER. Only a 3 month extension has been granted.

To extend the duration beyond the new expiry date (4 October 2018) the Licence Holder is required to submit an application for licence renewal for assessment by DWER. Renewal applications should contain the same level of detail as an application for a new licence.

It is recommended that an application for a licence renewal is submitted by the middle of July 2018 to allow sufficient time for DWER to undertake the assessment. Decision

The Delegated Officer has determined that an amendment is to be made to extend the Licence duration from 2 July 2018 to 4 October 2018. No additional changes are proposed.
