Amendment Notice

This Notice is issued under section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Licence L9183/2018/1 issued under the EP Act for a Prescribed Premises as set out below. This notice of amendment is given under section 59B (9) of the EP Act.

Amendment description

The Meteor Stone Pty Ltd licence (L9183/2018/1) expires on 21 November 2019 and the Licence Holder is yet to make application to renew this licence. Given the short timeframes to complete a licence review and given operations will continue, DWER has decided to initiate this amendment to the Licence L9183/2018/1 for the Meteor Stone operations providing sufficient time for completion of a comprehensive licence review during the next twelve months.
