Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Works Approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to extend the expiry date. No changes to the aspects of the original works approval relating to Category 12 have been requested by the Works Approval Holder.

Amendment description

An application for an amendment to Works Approval W5405/2013/1 was received by the Department on 28 March 2019. In the application, the Works Approval Holder requested an extension of the expiration date on W5405/2013/1 to 19 May 2022.

The development of a quarry on site was to provide aggregate to the following projects:

- -Recreational fisherman harbor facility in Broom;
- -Supply road base and sealing material for the Fitzroy River Great Northern Highway road realignment
- -Infrastructure requirements in the Derby port area

The above projects are yet to commence development, Kimberley Granite Quarries Pty Ltd believe that there will be action within the next three years and therefore wish to extend the expiry date of this works approval.

There has not been any further assessment of the approval.
