## Amendment

The Chief Executive Officer (CEO) of the Department of Water and Environmental Regulation (DWER) has amended the above Works Approval in accordance with section 59 of the *Environmental Protection Act 1986* (EP Act), as set out in this Amendment Notice. This Amendment Notice constitutes written notice of the amendment in accordance with section 59B(9) of the EP Act.

## Amendment Notice

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Works Approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

## Amendment description

This amendment is the result of an application submitted by the Works Approval Holder and relates to the extension of the Works Approval expiry date from 27 April 2019 to 27 April 2020 to allow additional time for commissioning under the Works Approval to be completed due to delays associated with the construction of infrastructure associated with the Wheatstone LNG plant. To facilitate continued commissioning, the Application also includes the extension of the commissioning periods specified in Conditions 1.2.2, 1.2.3 and 1.2.4.

## Decision

Section 63 of the EP Act prescribes that a works approval shall continue in force for such period as is specified in the works approval. Works Approval W5584/2014/1 is due to expire on 27 April 2019. The Delegated Officer has granted the amendment allowing the extension of the Works Approval for 12 months, and extension of the commissioning periods for an additional 6 months.

In determining to amend the duration of the works approval by 12 months, and the extension of the commissioning periods specified in Conditions 1.2.2, 1.2.3 and 1.2.4, the following matters were considered by the Delegated Officer:

- The risks posed by emissions from the premises during commissioning have not changed since the works approval was granted;
- By extending the duration of the Works Approval for a further 12 months, the Works Approval Holder will be able to complete commissioning required under the Works Approval and have sufficient time to compile commissioning reports required under the Works Approval;
- Monitoring of emissions and discharges will continue in accordance with the commissioning plan submitted in accordance with condition 2.1.1; and
- An application for a licence for the operation of the infrastructure is expected to be submitted in Quarter 1 2019. Extending the Works Approval will allow sufficient time for DWER to review the commissioning data and assess the licence application.

## Works Approval Holder's comments

The Works Approval Holder was provided with a draft Amendment Notice on 20 December 2018. The Works Approval Holder elected to waive the 21 day consultation period on 20 December 2018.

### Amendment

1. The Works Approval duration is amended from 27 April 2019 to 27 April 2020.
2. Conditions 1.2.2, 1.2.3 and 1.2.4 of the Works Approval are amended by the deletion of the text shown in strikethrough below and the insertion of the red text shown in underline below.
  - 1.2.2 *The Works Approval Holder shall commission the LNG Plant common facilities, LNG Train 1, and ancillary facilities ~~for a period not exceeding the timescale to be specified in the commissioning plan as required by IR2(a) of Condition 2.1.1 and for a period not exceeding 18~~ 24 months.*
  - 1.2.3 *The Works Approval Holder shall commission Train 2 of the LNG Plant and associated ancillary facilities ~~for a period not exceeding the timescale to be specified in commissioning plan as required by IR2(a) of Condition 2.1.1 and for a period not exceeding 12~~ 18 months.*
  - 1.2.4 *The Works Approval Holder shall commission the Domgas plant and ancillary facilities ~~for a period not exceeding the timescale to be specified in commissioning plan as required by IR2(a) of Condition 2.1.1 and for a period not exceeding 12~~ 18 months.*
