Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the works approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Works Approval History

Water Corporation (the Works Approval Holder) was granted a Works Approval on 15 August 2014 for the construction of the Bruce Rock Septic Tank Effluent Disposal (STED) Scheme under category 54 Sewage facility with a capacity of 100 cubic metres per day. The original application was to construct a secondary facultative pond, three maturation ponds and an evaporation pond; the evaporation pond was a contingency disposal method when the reuse scheme was not available. The Works Approval was then amended on 24 December 2015 to reduce the pond size for the secondary facultative and 3 maturation ponds based on experiences from the Hyden STED to achieve suitable water quality.

The Works Approval Holder was granted Amendment Notice 1 on 21 March 2017 for the construction of an additional clay lined evaporation pond, to amend the premises boundary to allow for the construction and operation of the new pond and, extending the duration of the works approval for the construction work to be completed.

Amendment description

On 5 December 2017, the Works Approval Holder applied for an extension to the Works Approval expiry date of 31 December 2017. The Works Approval Holder cited suspension of conveyance network construction due to latent conditions of the local terrain and scheme redesign as the reason for the application to extend the expiry date. The Licence Holder requested an extension of the expiry date until 31 December 2019.

Decision

The Delegated Officer considers that the extension of the Works Approval expiry date from 31 December 2017 to 31 December 2019 will not change the environmental risk profile of the Premises. The amended expiry date will allow the works to be completed as per the previously issued Works Approval. As such, the amendment has been granted.

Works Approval W5647/2014/1 expiry date has been amended to 31 December 2019.

Consultation

The Works Approval Holder was provided with the draft Amendment Notice 2 on 13 December 2017 for review and comment. The Works Approval Holder responded on 14 December 2017 waiving the remaining comment period. No comments were submitted on the draft Amendment Notice 2.

The Shire of Bruce Rock confirmed on 20 December 2017 that the two year extension to the works approval was supported and no local government planning approvals were required; it is also consistent with the Shire of Bruce Rock Town Local Planning Strategy.

Amendment

1. The Works Approval expiry date has been amended from 31 December 2017 to 31 December 2019.
