### **Amendment Notice**

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Works Approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This notice is limited only to an amendment to extend the expiry date of the Works Approval. No changes to the aspects of the original Works Approval have been requested by the Works Approval Holder.

The following guidance statements have informed the decision made on this amendment:

- Guidance Statement: Regulatory Principles (July 2015);
- Guidance Statement: Setting Conditions (October 2015);
- Guidance Statement: Land Use Planning (February 2017);
- Guidance Statement: Licence Duration (August 2016);
- Guidance Statement: Decision Making (February 2017);
- Guidance Statement: Risk Assessment (February 2017); and
- Guidance Statement: Environmental Siting (November 2016).

## **Amendment description**

The Works Approval currently expires on 24 August 2019. The Works Approval Holder has requested that this be extended. This Works Approval provides construction approval for Stage 7, 8 and 9 embankment rises on the TSF. Stage 7 has been completed in 2015 and as part of this, an additional groundwater monitoring bore was added at the northwest perimeter of the extended embankment. This can be added onto the Licence when next amended. Stage 8 and 9 have not commenced as the site went into Care and Maintenance in 2018.

The Works Approval Holder is currently in exploration onsite ready to reopen the operations and once this occurs the Stage 8 embankment rise will be required to provide capacity for tailings deposition.

It should be noted that the Licence (L7969/2004/3) was previously subject to a Groundwater Management Plan improvement condition due to potential seepage issues with the TSF. Elevations in TDS, sulfate/chloride, magnesium/sodium and calcium/sodium ions and lower alkalinity have been noted in the groundwater surrounding the TSF.

A sulfate trigger value of 5,000mg/L is present on the Licence for the TSF groundwater monitoring bores (PMB1-PMB10) and a sulfate trigger value of 2,000mg/L for Production Bore PB45 (located between the TSF and nearest downstream pastoral bore PB70 that is currently used for livestock drinking water), with seepage recovery initiated if these trigger values are exceeded. The trigger values were not exceeded during the 2017-2018 reporting period.

Following a water quality review and groundwater modelling exercise at the mine, Contaminated Sites Branch provided technical advice and found that "Groundwater quality problems in the mine area are probably mostly caused by the drawdown of the water table rather than by seepage from the TSF" (CSB, 2016).

#### **Decision**

The TSF lifts 7, 8 and 9 were assessed during the original Works Approval assessment. Lift 7 has been completed and implemented onto the operating Licence L7969/2004/3.

The Works Approval expiry date has been extended for an additional five years to allow for the additional lifts to occur. Potential seepage issues have been identified and monitoring is occurring to ensure that seepage recovery management measures are implemented if trigger values are exceeded. Monitoring results were within set trigger values during the 2017-2018 reporting period. It has been noted, however, that it is more likely groundwater drawdown that is impacting on groundwater quality, as opposed to TSF seepage.

## **Works Approval Holder's comments**

The Works Approval Holder was provided with the draft Amendment Notice on 14 May 2019. The Works Approval Holder responded on the 14 May 2019 waiving the remaining comment period with no comment (until 9 June 2019).

#### **Amendment**

1. The Works Approval expiry date has been extended from Saturday, 24 August 2019 until **Saturday**, **24 August 2024**.
