## 2. Amendment description

This amendment is made pursuant to section 59 of the *Environmental Protection Act 1986* (EP Act) to amend the Works Approval issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

This amendment is a DWER initiated amendment to remove infrastructure required to be installed under Works Approval W6192/2018/1, namely the screening plant, crushing plant and pug mill.

The Works Approval Holder has advised that they do not intend to bring these pieces of infrastructure on-site until they receive a licence to operate the Premises, as it is uneconomical to store these items prior to use.

The Works Approval Holder is unable to demonstrate compliance with the Works Approval, and therefore submit a licence application, while these items are specified within the Works Approval.

Delaying the installation of the infrastructure does not alter the risk profile of the proposed Premises. These items are critical to the operation of the Premises and any Licence issued for the Premises will specify that the same infrastructure is installed prior to operation commencing.

The Works Approval Holder will still be required to demonstrate compliance with the rest of the Works Approval, including the other pieces of infrastructure, prior to a Licence application being accepted for assessment, which is consistent with the provisions of the EP Act.

## 3. Works Approval Holder's comments

The Works Approval Holder was provided with the draft Amendment Notice on 1 May 2019. The Works Approval Holder notified DWER on 7 May 2019 that they wished to waive the comment period.

### 4. Decision

The Delegated Officer has determined that the screening plant, crushing plant and pug mill will be removed from the Works Approval, to enable the Works Approval Holder to demonstrate compliance with the Works Approval and apply for a Licence to operate. These changes have been shown below:

1. Table 2 of Condition 4 is amended by the deletion of the text shown in strikethrough below:
