Amendment Notice

This notice is issued under section 59 of the *Environmental Protection Act* 1986 (EP Act) to amend the licence issued under the EP Act for a prescribed premises as set out below. This notice of amendment is given under section 59B(9) of the EP Act.

Amendment Description

This Amendment Notice is the result of a written request by the Licensee to relocate the Depot Hill ambient air monitoring location 'AQ2, AQ5', as the current power supply to this location is about to be disconnected due to rehabilitation earthworks in the area. A suitable alternative location has been proposed, approx. 700 m north-east of the current location, that will allow for the continued monitoring of background ambient air quality whilst rehabilitation earthworks of nearby open areas is completed.

Decision

DER has amended the Map of Monitoring Locations in Schedule 1 of L5646/1994/10 as per the request. There is no change in the assessed risk profile as monitoring of ambient air quality at the Depot Hill background location will continue.
