"The department notes that the site is currently classified as *Contaminated – Remediation Required* under the *Contaminated Sites Act 2003*. The department further notes that remedial actions have been undertaken on the premises, the results of which have been validated by a Mandatory Auditor's Report. As part of the remedial works undertaken, the processing plant was dismantled and removed from the premises."

Horizon Minerals is in the process of finalising the Contaminated sites work by lodging an interest only deposited plan with Landgate to allow the reclassification of the site to remediated-restricted use as per the recommendation of the Mandatory Auditor's Report (See MP43836 Project Layout with Contaminated Site).

The current version of the Nimbus Licence has a through put stated as 50,000 tonnes or more per year. An administrative error appears to have occurred in the February 2021 renewal:

Previous licence:

"category production/design capacity" 50 000 tonnes or more per year

"assessed production/design capacity" 120 000 tonnes per annual period

The assessed production/design capacity should be 120,000 tonnes or more per year not 50,000 tonnes or more per year. Horizon request this be reflected in the renewed licence.
