Operators not applying enough cover as the wastes (e.g. plastics) are not compacting well meaning greater amounts of cover need to be applied.					
Action taken to mitigate any adverse effects of non-compliance and prevent recurrence of the non-compliance:					
Where possible, shredded material has placed as the final layer of waste prior to covering to get a smother surface. Opalvale also commenced using of a mineral-based spray-on alternative daily cover to ensure coverage of waste.
