1. Decision summary

The Delegated Officer has determined to transfer licence L6533/1993/11 from the existing licence holder BGC (Australia) Pty Ltd to Swan Materials Pty Ltd. The transfer is administrative in nature therefore does not alter the risk profile of the Premises. No changes to the activities, emissions or discharges are proposed or permitted to be undertaken by the new occupier without further application to amend licence L6533/1993/11.

2. Scope of assessment

2.1 Regulatory framework

In completing the assessment documented in this transfer report, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Transfer summary

Licence L6533/1993/11 was held by BGC (Australia) Pty Ltd. On 10 November 2025 the department received an application to transfer the licence to a new licence holder, Swan Materials Pty Ltd under section 64 of the EP Act.

Licence L6533/1993/11 relates to the BGC Hazelmere Industrial Complex, located on Corner Bushmead Road and Stirling Crescent.

The transfer is limited solely to updating the licence holder's business name, registered business address and ACN.

3. Assessment

The assessment of the transfer application for Licence L6533/1993/11 involves verifying legal occupancy and reviewing department records to confirm the fitness and competency of the applicant.

Legal Occupancy

Swan Materials Pty Ltd has provided a valid lease agreement as part of the transfer application. The lease term extends at least until the licence expiry date, confirming legal occupancy of the premises for the required duration.

Legal Entity Status

Swan Materials Pty Ltd is a registered company with a current entry on the Australian Securities and Investments Commission (ACN 626 554 407), confirming its status as a legal
