## 1. Decision summary

The Delegated Officer has determined to make amendments to Licence L7917/2000/6. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

## 2. Scope of assessment

#### 2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

### 2.2 Application summary

Licence L7817/2000/7 is held by Orminex West Pty Ltd (Licence Holder) for the Sand Queen Dewatering Project (the Premises), located at Mining tenements M29/52, M29/233, M29/321, L29/67. The transferring of the instrument to a new holder causes the instrument to be issued as a new version.

The Premises relates to the category 6 and the assessed production capacity of 1,500,000 tonnes per annual period under Schedule 1 of the *Environmental Protection Regulations* 1987 (EP Regulations) which are defined in existing Licence L7817/2000/7.

On 22 May 2025, the Licence Holder submitted an application to the department to amend Licence L7817/2000/7 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to a transfer of licence occupier from Sand Queen Gold Mines Pty Ltd to Orminex West Pty Ltd.

#### 3. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

## 3.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the Revised licence as part of the amendment process.
