1. Decision summary

The Delegated Officer has determined to transfer licence L8452/2010/2 to Moore Sands Resources Pty Ltd. The transfer is administrative in nature therefore does not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

2. Scope of assessment

2.1 Regulatory framework

In completing the assessment documented in this decision report, the Department of Water and Environmental Regulation (the department; DWER) has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

On 25 February 2025, the applicant submitted an application to the Department to transfer licence L8452/2010/2 under section 59B of the *Environmental Protection Act 1986* (EP Act) from Castle Equipment Hire Pty Ltd to Moore Sands Resources Pty Ltd.

The premises relates to category 12, crushing and screening and assessed production capacity under Schedule 1 of the Environmental Protection Regulations 1987 (EP Regulations) which are defined in licence L8452/2010/2.

3. Assessment

The assessment of transfer applications requires determination of whether the new occupier meets the department's fitness and competency requirements. The applicant must provide documentary evidence of the date they became occupier of the premises.

Legal occupancy

A record of certificate of title was provided demonstrating that Gregory William Murray (Director of Moore Sands Resources Pty Ltd) is the registered proprietor of the premises (51 Guilderton Road). The certificate of title was registered on 13 July 2023.

Legal entity status

Moore Sands Resources Pty Ltd is a registered company with a valid and current entry on the Australian & Investments Commission register (ACN 117 087 215) and is therefore a legal entity.

Fitness and competency

The applicant advises they have not been convicted or paid a penalty for an offence under a provision of the EP Act or its subsidiary legislation or similar environmental protection legislation. Further, a review of the department's internal Incidents and Complaints Management System did not identify and complaints or potential offences against the applicant.

4. Conclusion

The Delegated Officer has determined to transfer the licence with a revised version number (L8452/2010/3) to Moore Sands Resources Pty Ltd on the grounds it is a current legal entity with legal access to the premises and has no known convictions.
