## 1. Decision summary

Licence L8466/2010/3 is held by the Water Corporation (Licence Holder) for the Southern Seawater Desalination Plant (the Premises), located at Lot 100 on Plan 70153, Binningup WA 6233.

The Delegated Officer has determined to make amendments to Licence L8466/2010/3. The amendments outlined within this amendment report do not alter the risk profile of the Premises. As a result of this assessment, Revised Licence L8466/2010/3 has been granted.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The Revised Licence issued as a result of this amendment consolidates and supersedes the existing Licence previously granted in relation to the Premises. The Revised Licence has been granted in a new format with existing conditions being transferred, but not reassessed, to the new format.

The decision report for the Existing Licence will remain on the department's website for future reference and will act as a record of the department's decision making.

# 2. Scope of assessment

## 2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

## 2.2 Application summary

On 13 March 2023, the Licence Holder submitted an application to the department to amend Licence L8466/2010/3 under section 59 and 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to altering the due date for the Annual Audit Compliance Report and the environmental report, to be 19 April. Biennial reporting for the environmental report has been previously approved under the Notice of Amendment of Licence Reporting Requirements effective 16 May 2022.

No changes to the aspects of the Existing Licence relating to Category 54A have been requested by the Licence Holder. Table 1 below outlines the current approved production/design capacity for the Premises.

#### 2.3 Consolidation of Licence

As part of this amendment package the department has consolidated the licence by incorporating changes made under the Amendment Notices as summarised in Table 1.

The obligations of the Licence Holder have not changed in consolidating the licence. The department has not undertaken any additional risk assessment of the Premises related to previous Amendment Notices.

In consolidating the licence, the CEO has:

- updated the format and appearance of the Licence;
- revised licence condition's numbers, and removed any redundant conditions and realigned condition numbers for numerical consistency; and
- corrected clerical mistakes and unintentional errors.

The full consolidation of licence conditions as they relate to this Revised Licence are detailed in Section 4.1. Previously issued Amendment Notices will remain on the department's website for future reference and will act as a record of the department's decision making.

### 3. Consultation

On 26 June 2023 the Licence Holder provided comment on the draft revised Licence and amendment report advising the Licence should proceed to issuing.

### 4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that a Revised Licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
