1. Decision summary

The Delegated Officer has determined to transfer Licence L8495/2010/2. The transfer is administrative in nature therefore does not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

The decision report for the existing Licence L8495/2010/2 will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In completing the assessment documented in this decision report, the Department of Water and Environmental Regulation (the department; DWER) has considered and given due regard to its regulatory framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Licence L8495/2010/2 is held by Mount Gibson Mining Limited (Licence Holder) for the Extension Hill Mine Site (the Premises), located in Mining Tenements G59/33, G59/34, G59/62, L59/68, L59/69, L59/87, M59/338, M59/339, M59/526, M59/454, M59/455 and M59/609, PAYNES FIND WA 6612 approximately 71 km north east of Latham.

The Premises is licenced for Categories 5, 63, 64 and 85 under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) with assessed production capacities defined in existing Licence L8495/2010/2.

On 03 November 2023 an application was submitted to the department for a transfer of licence L8495/2010/2 under the section 61 of the *Environmental Protection Act 1986* (EP Act).

Licence transfer limited to changing the:

- Licence holder's name from Mount Gibson Mining Limited to Terra Mining Pty Ltd;
- Australian Company Number (ACN) from 074 575 885 to 605 732 518;
- Registered business address from Level 1, 2 Kings Park Road WEST PERTH WA 6005 to 2/225 St Georges Terrace PERTH WA 6000; and
- Mining tenement G59/30 has been replaced by Mining tenement G59/62.

There are no proposed changes to the current approved premises categories or design capacity.

3. Assessment

The assessment of transfer applications requires the determination of whether the new occupier meets the department's fitness and competency requirements. The applicant must provide documentary evidence of the date they became occupier of the premises.

Legal occupancy

Mining tenure registrations applicable to the transfer of licence were provided demonstrating that Extension Hill Pty Ltd is the registered owner of the tenement on which the premises is located. Terra Mining Pty Ltd and Extension Hill Pty Ltd have a letter of operational control.

Mining tenement G59/30 has been replaced by Mining tenement G59/62.

Legal entity status

Terra Mining Pty Ltd is a registered company with a valid and current entry on the Australian & Investments Commission register (ACN 605 732 518) and is, therefore, a legal entity.

Fitness and competency

The applicant advises it has not been convicted or paid a penalty for an offence under a provision of the EP Act or its subsidiary legislation or similar environmental protection legislation in Australia

4. Conclusion

The Delegated Officer has determined to transfer licence L8495/2010/2 to Terra Mining Pty Ltd on the grounds it is a current legal entity with legal access to the premises.

4.1 Summary of amendments
