## 1. Scope of amendment

#### 1.1 Amendment summary

Ivan Rogers & Simon Rogers (licence holder) hold licence L8547/2011/1, issued under Part V Division 3 of the *Environmental Protection Act 1986*. The licence is due to expire on 7 September 2023.

The licence relates to operation of a cattle feedlot complex about 20 km north of Quairading. The main activities occurring on the premises include the holding and feeding of cattle, and management of manure, effluent and mortalities generated from operations.

The department has previously indicated its intentions to review the licence as part of replacing the expiring licence in 2023, including an audit of the design and operational aspects of the feedlot against the *National Beef Cattle Feedlot Environmental Code of Practice* (MLA 2012) (Code). However, due to time constraints, the department has been unable to commence the review and instead proposes to defer this process for a further 12 months.

#### 2. Decision

The delegated officer has determined to extend the duration of the existing licence as an administrative change, on the grounds of time constraints to complete a detailed review, and that it does not change the obligations of the licence holder in the interim.

The licence duration will be extended by 12 months, now expiring in 2024, in which time it is anticipated the department will have completed its review of the licence, taking into consideration a self-audit of the feedlot against the Code that is currently being conducted by the licence holder.

In extending licence duration, the delegated officer has also determined to:

- replace references to the 'Director' and former-Department of Environment and Conservation;
- update condition 7 relating to annual audit compliance reporting requirements, consistent with the current DWER licence template;
- remove Attachment 1, being a superseded AACR template; and
- updated Attachment 2, with a more recent map of the premises.

#### 3. Consultation

The draft licence and this report were provided to the licence holder on 10 July 2023, who did not provide a response within the specified timeframe.
