1. Decision summary

The delegated officer has determined to make amendments to licence L8789/2013/1. The amendments are administrative in nature therefore they do not alter the risk profile of the premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Application summary

Licence L8789/2013/1 is held by Tox Free Australia Pty Ltd (Tox Free) for the South Boulder Liquid Waste Services facility (premises) at 31 Vivian Street, South Boulder.

In May 2018, Tox Free was acquired by Cleanaway Co Pty Ltd (Cleanaway).

On 19 September 2023, Cleanaway submitted an application to amend the licence under section 59B of the EP Act, to update the licence holder name to Cleanaway Co Pty Ltd and the premises name to Cleanaway Co Kalgoorlie.

The ACN remains unchanged (127 853 561).

3. Consultation

Cleanaway was provided with the draft amended licence and this report on 19 December 2023, no comments were received within the consultation period.

4. Decision

The delegated officer has determined to amend the licence to reflect the change of company name to Cleanaway Co Pty Ltd and the premises name to Cleanaway Co Kalgoorlie.

The licence remains in an older format; updates have been made to contemporise annual audit reporting requirements and administrative updates to the department and CEO contact details have also been made.

In noting the age and format of the licence, the delegated officer also notes the absence of site-specific conditions that are required for facilities that accept waste, such as waste acceptance criteria, waste treatment requirements, an authorised infrastructure table, and other record keeping and reporting requirements.

It is therefore noted that the licence should reviewed at the next available opportunity, to update to the current licence format and to ensure all emissions and discharges have been properly identified, and there is an appropriate level of regulatory control being applied commensurate to the risk of impacts from ongoing operations to public health and the environment.

4.1 Summary of amendments

Table 1 below provides a summary of the proposed amendments and will act as a record of implemented changes. All proposed changes have been incorporated into the revised licence as part of the amendment process.
