# 1. **Decision summary**

The Delegated Officer has determined to make amendments to Licence L8854/2014/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing licence will remain on the department's website for future reference and will act as a record of the department's decision making.

### **1.1 Regulatory framework**

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <u>https://dwer.wa.gov.au/regulatory-documents</u>.

### **1.2** Amendment summary

Licence L8854/2014/1 is held by Shire of Broomehill-Tambellup (Licence Holder) for the Broomehill Waste Management Facility (the Premises), located at Tie Line Road, Broomehill WA.

The Premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L8854/2014/1.

The department considers there to be insufficient time to complete a licence renewal prior to the current licence expiry. Therefore, the licence duration will be extended for a short period to ensure the current licence continues to remain in force until a full assessment is able to be completed.

The department initiated an amendment to Licence L8854/2014/1. The amendment is limited to extending licence expiry date; renumbering of conditions; annual reporting period; typographical errors; updating/deletions/inclusion of definitions, etc.

## 2. Consultation

The Licence Holder was provided with the draft Amendment Report on 20 December 2024. The licence holder did not provide comment on the draft package.

## 3. Summary of amendments
