APPLICATION FOR A LICENCE (L9180/2018/1) UNDER THE ENVIRONMENTAL PROTECTION ACT 1986 – NOTICE OF DECISION TO GRANT

I refer to Brajkovich Demolition and Salvage Pty Ltd's (Brajkovich) application for a licence (L9180/2018/1) relating to operating a crushing and storage facility at 10 Bonner Drive in Malaga. This application was received by the Department of Water and Environmental Regulation (DWER) on 19 February 2018.

A draft licence was provided to you on 21 December 2018. After considering the comments you provided on that same day waiving the remainder of the comment period, I have granted the attached licence subject to the conditions prescribed in the instrument. The attached Decision Report sets out the reasons for my decision.

In accordance with section 102(1)(c) of the EP Act, if you are aggrieved by my decision to specify conditions in the licence, you may lodge an appeal with the Minister for Environment in writing, setting out the grounds of that appeal, within 21 days of this notification. Under section 102(3)(a) of the EP Act, third parties aggrieved by this decision are also entitled to lodge an appeal against the conditions of a licence. Under section 102(4), the conditions of the licence remain in effect pending the determination of any third party appeals.
