## 1. Decision summary

The Delegated Officer has determined to transfer licence L9185/2018/1 from the existing licence holder WMines Limited to BBL Milling Pty Ltd. The transfer is administrative in nature therefore does not alter the risk profile of the premises. No changes to the activities, emissions or discharges are proposed or permitted to be undertaken by the new occupier without further application to amend licence L9185/2018/1.

## 2. Scope of assessment

# 2.1 Regulatory framework

In completing the assessment documented in this decision report, the Department of Water and Environmental Regulation (the department; DWER) has considered and given due regard to its regulatory framework and relevant policy documents which are available at <a href="https://dwer.wa.gov.au/regulatory-documents">https://dwer.wa.gov.au/regulatory-documents</a>.

## 2.2 Transfer summary

Licence L9185/2018/1 was held by WMines Limited. On 8 October 2025 the department received an application to transfer the licence to a new licence holder, BBL Milling Pty Ltd under section 64 of the EP Act.

Licence L9185/2018/1 relates to the Burbanks Treatment Plant, located on Mining tenements M15/1273, M15/1369, M15/1370, G15/10, G15/11, G15/12, G15/13, G15/25 and L15/110.

The transfer is limited solely to updating the occupier's business name and registered business address and ACN. The licence version will be updated following the transfer to L9185/2018/2.

## 3. Assessment

The assessment of the transfer application involves verification of the legal occupancy details and a review of department records to establish the fitness and competency of the applicant.

#### Legal occupancy

As part of the application for the transfer of L9185/2018/1, valid transfers of all applicable mining tenements between WMines Limited (transferor) and BBL Milling Pty Ltd (transferee) were provided.

#### Legal entity status

BBL Milling Pty Ltd is a registered company with a valid and current entry on the Australian Securities & Investments Commission register (ACN 682 920 181) and is therefore a legal entity.

#### Review of department records

A review of department records including the Incident and Complaints Management System, Content Manager and Environment Online produced no evidence of infringements or non-compliance. As such BBL Milling Pty Ltd as an entity has been determined to be fit and competent to hold L9185/2018/1.

### 4. Conclusion

Based on the assessment in this Transfer Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
