1. Decision summary

The Delegated Officer has determined to transfer Licence L9191/2019/2 from the existing licence holder, Cleanaway Pty Ltd to Veolia Environmental Services (Australia) Pty Ltd. The transfer is administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the transfer made pursuant to section 64 of the *Environmental Protection Act 1986* (EP Act). The decision report for the existing Licence L9191/2019/1 will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the licence, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Transfer application summary

Licence L9191/2019/1 is held by Cleanaway Pty Ltd (Licence Holder) for the Albany Transfer Station, (the Premises), located at Lot 167 Cuming Road, Mount Melville WA.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Licence L9394/2023/1.

On 26 June 2025, the Licence Holder submitted an application to the department for a transfer of licence L9191/2019/1 under the section 61 of the Environmental Protection Act 1986 (EP Act).

The transfer application is limited only to changing Licence holder's name (Occupier's name) from Cleanaway Pty Ltd to Veolia Environmental Services (Australia) Pty Ltd, updating occupier's registered business address, and Australian Company Number (ACN) from 000 164 938 to 051 316 584.

3. Consultation

The Licence Holder was provided with the draft Amendment Report on 24 July 2025. On 1 August 2025 the Licence holder requested the licence to be issued and waived the remainder of the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended licence will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
