1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6260/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the Existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at https://dwer.wa.gov.au/regulatory-documents.

2.2 Application summary

Works Approval W6260/2019/1 is held by Kimberley Quarry Pty Ltd (Works Approval Holder) for the Maitland Quarry (the Premises), located within mining tenement M47/1496, Maitland.

The Premises relates to the category and the assessed production capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6260/2019/1.

On 13 June 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6260/2019/1 under section 59B of the *Environmental Protection Act* 1986 (EP Act). The amendment is limited only to extending the works approval expiry date.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 24 July 2025. On 25 July 2025 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.
