1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6315/2019/1. The amendments are administrative in nature therefore they do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report and previous amendment reports for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Amendment summary

Works Approval W6315/2019/1 is held by IB Operations Pty Ltd (Works Approval Holder) for the Iron Bridge Magnetite Project (the Premises), located at mining tenements M45/1226, M45/1244, L45/293, L45/294, L45/359, L45/360, L45/361, L45/364 and L45/367.

The Premises relates to the categories and the assessed design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6315/2019/1.

On 02 October 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6315/2019/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited only to extending the works approval expiry date from 31 December 2025 to 31 December 2026 (extension of a year).

The Works Approval Holder has requested the extension to ensure that the works approval remains valid whilst the remaining items of infrastructure and their associated Environmental Compliance Report(s) are submitted and subsequently transferred to the Iron Bridge Mine Site Licence L8845/2014/1.

The department notes that this is the third duration extension sought for the works approval. Nominally, works approval durations are set at a 3-5 year period. Further extensions may not be afforded.

3. Consultation

The Works Approval Holder was provided with the draft Amendment Report on 19 November 2025. On 20 November 2025 the Works Approval Holder waived the comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
