1. Decision summary

The Delegated Officer has determined to make amendments to Works Approval W6403/2020/1. The amendments are administrative in nature and therefore do not alter the risk profile of the Premises, providing that activities, emissions and receptors as stated in existing approvals remain unchanged.

This Amendment Report documents the amendments made pursuant to section 59 and 59(B) of the *Environmental Protection Act 1986* (EP Act).

The decision report for the existing works approval will remain on the department's website for future reference and will act as a record of the department's decision making.

2. Scope of assessment

2.1 Regulatory framework

In amending the works approval, the department has considered and given due regard to its Regulatory Framework and relevant policy documents which are available at <https://dwer.wa.gov.au/regulatory-documents>.

2.2 Application summary

Works Approval W6403/2020/1 is held by Hamersley HMS Pty Ltd (Works Approval Holder) for the Hope Downs 4 Iron Ore Mine (the Premises), located at Mining Lease (ML) 282SA and ML5SA near Newman, Western Australia.

On 29 January 2025, the Works Approval Holder submitted an application to the department to amend Works Approval W6403/2020/1 under section 59B of the *Environmental Protection Act 1986* (EP Act). The amendment is limited to extending the works approval expiry date by two years and updating the Works Approval Holder's Australian Company Number (ACN) due to typographical error in the original instrument. The change to the expiry date is required to allow for the commissioning of Kalgan Pit 4 which has been extended to beyond Q1 2026.

The Premises relates to the category and the assessed production/design capacity under Schedule 1 of the *Environmental Protection Regulations 1987* (EP Regulations) which are defined in existing Works Approval W6403/2020/1.

3. Consultation

The Works Approval Holder was provided a copy of the draft assessment package on 14 March 2025. On 03 April 2025 the Works Approval Holder confirmed they had no comment and waived the remaining comment period.

4. Conclusion

Based on the assessment in this Amendment Report, the Delegated Officer has determined that an amended works approval will be granted, subject to conditions commensurate with the determined controls and necessary for administration and reporting requirements.

4.1 Summary of amendments
